## **Executive Summary**

Annually, Passaic County must review and report its progress in carrying out its Five-Year Strategic Plan and the Annual Action Plan.

During FY 2023, Passaic County received \$965,848.00 in CDBG funding. Funds were allocated to public facility improvements, street improvements, handicap barrier removal projects, water and sanitary sewer improvements, public services and administration. The table below shows the projects awarded for FY 2023, Sept 1, 2023 to August 31, 2024.

- Bloomingdale Senior Center Pavilion
- Passaic County Habitat for Humanity Critical Repair Program: Completed in Fall 2024
- FY 22 CASA: Court Appoitneed Advocacy for Child Abuse Victims
- FY 21, FY 22, FY 23 Home Care Options
- Borough of Little Falls Street Reconstruction (Mozart and Cherry Streets): Completed in fall 2024
- Borough of Pompton Lakes Hershfield St Improvements: Completed in Fall 2024
- Borough of Prospect Park 11<sup>th</sup> Street Improvements: Completed in Fall 2024

The design and bidding of many of the FY 2022 and 2023 projects got underway in 2023; bids that have not yet gone out will go out in late 2024 with work to begin spring 2025. Many public service activities will continue, with older year funding being spent first. Projects underway include:

- Improvements to the Woodland Park Library: Bid and under construction in Fall 2024
- Borough of Totowa Sanitary Sewer Lining (Franklin Place, Lincoln Place, Willard Ave)
- Borough of Wanague Park Avenue Improvements: Bid and under construction in Fall 2024
- Borough of Hawthorne Sidewalk Improvements: Bid and under construction in Fall 2024
- West Milford Township ADA Improvements at the Township Building: In Design, evaluating structural integrity of building prior to bidding as of Fall 2024

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The County continued to use funds to address the high priority needs for infrastructure, facility improvements, and public services as identified in the Five-Year Plan. CDBG funds have been directed to the twelve participating municipalities in the Urban County. The highest priority infrastructure needs in lower income neighborhoods were addressed through the use of CDBG funds.

This is the first report of the Five-Year period 2023-2027. This report captures data from projects that were initially funded in years 2018-2022. Many projects take more than one year to complete, particularly as construction costs continue to escalate and supply chain issues delay materials and equipment needed for some projects. In addition to the projects completed above, the County continued to support CDBG-CV projects. A substantial amendment awarded funds to a generator for the Woodland Park Library, which is used as a warming station and quarantine center. In addition, funds are being directed to the rehabilitation of a facility in West Milford to be used as a satellite health clinic for COVID treatment and vaccines. The County's CDBG-CV also continued to fund public services including services for the elderly and legal services for those experiencing housing challenges as a result of COVID and residual pandemic effects.

Race and Ethnicity are not reported in IDIS for area benefit activities. The above totals are for activities that serve low-income persons under the Limited Clientele national objective such as handicap barrier removal and public services.

The areas of the Passaic County Urban County that have a concentration of Non-White and Latino populations are limited but have increased since 2000. Census Block Groups in Haledon, Prospect Park, Wanaque, Pompton Lakes, and Woodland Park have higher concentrations of Non-White and Latino households in addition to concentrations of low- and moderate-income people.

### Narrative

The amount expended during the year is \$597,634.84. The funds were expended as shown in PR26 and PR03 and described in the Executive Summary.

Passaic County is part of the North Jersey Sustainable Communities Consortium. In November 2011, HUD notified the Consortium that its application had been selected for an award in the amount of \$5 million. Through participation in this program, the region expects to address broad livability and sustainability goals for housing, economic development and transportation.

The County drew down funds in 2023 to reimburse municipalities for several activities that were completed and beneficiaries reported in previous years.

### **Narrative**

There is no target area – the County selects projects based on requests from participating jurisdictions and non-profit agencies.

The CDBG Program tends to be highly leveraged with local funds in Passaic County. Communities bond for the project costs.

Municipalities are required to pay for design, engineering, traffic control and construction management. Construction funds that are not provided by CDBG but are necessary to complete the project are provided by the municipality. The participating municipalities report this matching expense on their applications as well as their commitment for other funds to cover the full project costs. The cost of design and technical assistance for the above projects was provided directly by each municipality.

The County is not a HOME or ESG participating jurisdiction and has no matching fund requirements.

# Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The County had awarded funds to Habitat for Humanity to administer a Critical Repair Program. The demand for the program far exceeded the amount of funds available, and the county intends to allocate excess funding to the program. Seven households received rehabilitation assistance in 2023.

### Discuss how these outcomes will impact future annual action plans.

The County will endeavor to identify and support affordable housing programs and the CoC in the creation of housing for persons who are experiencing homelessness. Housing projects may or may not be funded with the limited CDBG funding available to the County.

With the County's CDBG funds, there have been no housing activities or services directed to the homeless or persons with special needs undertaken through CDBG funding. Past CDBG CV funds,

however, were directed to both housing for the homeless and a special needs housing project to protect residents from the spread of COVID.

To address worst case needs and those of persons with disabilities, the County has taken the lead with the County-wide CoC and provided support over many years. The County administers HUD SHP grants to several non-profits providing dozens of permanent supportive housing units. These units provide housing for chronic homeless individuals and families. By definition these persons are disabled and homeless.

### **Narrative Information**

The County does not have a HOME Program. CASA clients are presumed benefit and do not require income verification to determine eligibility. Passaic County's Habitat for Humanity Critical Repair Program completed seven rehabilitations during the program year. All homeowners assisted were moderate income.

# CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

The Passaic County Continuum of Care (CoC) is supported by the staff of the Department of Human Services and administered by the Passaic County Interagency Council on Homelessness. The Passaic County community development goals are based on the work of the CoC in setting policies and implementing programs to prevent homelessness and assist persons who are homeless.

# Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

# Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

NJ 2-1-1 provides a point of access for shelter and emergency services. When someone calls 2-1-1 for shelter placement, diversion and eligibility screening is conducted to streamline access. Further, the CoC maintains a coordinated assessment and prioritization list to place individuals in permanent supportive housing.

During the year, provider agencies regularly provided outreach to homeless individuals living on the street and to those at risk of becoming homeless. The PATH Program provides regular outreach at known locations. Further, through partnership with the eviction courts, PATH has addressed the needs of those at-risk of losing their housing. When families are removed from the welfare list, outreach is conducted to see if they have short-term places to live and long-term plans for permanent housing. Additional street outreach is conducted by "They Have A Name" to encourage people to move to shelter and services.

The SSVF and Community Hope coordinate street outreach to homeless veterans.

During COVID, the County initiated testing and the use of hotel/motel residences to deconcentrate the shelters and prevent the spread of the virus. CV2 funds issued through NJDCA were used for testing and education and for the operation of a health clinic.

### Addressing the emergency shelter and transitional housing needs of homeless persons

Passaic County has 280 voucher/facility based beds across multiple programs (HIC 2024), plus 347 overflow beds. The PCICH works with all the shelters in the County to ensure capacity to meet emergency needs. All the shelters and transitional housing facilities participate in the Point-in-Time count and provide client level information to the Housing Prioritization List to connect their clients to permanent housing opportunities as quickly as possible, as described above. In addition, NJ-211 provides a streamlined hotline for accessing emergency shelter and transitional housing programs, reducing the need for clients to contact each emergency shelter or transitional housing program directly.

The Passaic County Homeless Trust Fund has also funded rapid re-housing and services in support of

rapid re-housing projects.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Catholic Family and Community Services is one of the larger service providers in Passaic County. As noted in the City of Paterson CAPER, CFCS works with the local hospitals when discharging patients. Services are provided through 2-1-1 and hotel vouchers are used to provide housing.

More needs to be done to address youth leaving foster care and other youth facilities. Although funding is available through the County to provide housing up to age 25, many youth simply want to leave the system. Youth homelessness continues to be a focus area for the CoC.

The State of New Jersey's psychiatric hospitals follow state guidelines that prohibit the discharge of patients into homelessness. All persons must have housing secured upon release or they remain in the hospital system until it is secured. The privately funded mental health residential programs are either state funded and abide by the protocols or choose to do so voluntarily.

Correctional facilities in Passaic County have established protocols for discharge. Social work staff coordinate with County Board of Social Services housing placement upon an individuals' release. There is a Re-Entry Policy Academy which focuses on ex-offenders re-entering communities. Upon discharge, Project PRIDE helps individuals to access mainstream resources and benefits from Passaic County Board of Social Services. To ensure appropriate supportive services upon discharge, an individualized discharge plan, with referrals to appropriate community agencies, is created. In addition, a life skills class is offered to eligible recipients to ensure integration into the community. The first 60 days of the class takes place in jail and the last 30 days takes place at the Passaic County Board of Social Services after release from jail. A meeting of various County agency representatives (mental health, DHS, workforce) and the PREP (Passaic County Re-Entry Program) members (social workers at the Passaic County jail) is held to discuss and strengthen the coordination for discharges from jails.

Passaic County does not receive Emergency Solutions Grant funds, however the City of Paterson does. The ESG funds are used to provide prevention services to extremely low- to very low-income households facing homelessness. No direct rent assistance is provided through the federal grant programs.

NJ 2-1-1 operates a homeless hotline. Persons who are in imminent threat of losing their homes are referred to the County Board of Social Services. ERAP funds distributed in response to COVID provided

\$36 million in rental assistance for County households.

The County administers the Division of Weatherization and Home Energy whose objective is to reduce the home energy burden for eligible low-income families and individuals in Passaic County to avoid homelessness. Passaic County assists low-income individuals and families through Home Energy benefits that reduce clients' energy bills and by implementing weatherization measures that reduce households' energy consumption.

The Low-Income Home Energy Assistance Program; and the Universal Services Fund provides grants to low-income individuals to pay their PSE&G bills. These funds help to keep low-income individuals and families in their homes and help them to not become homeless. In addition, the County offers a Weatherization Program funded through the Low-Income Energy Assistance Program grant; US Department of Energy grant; and the Heating Improvement Program grant. These grants help low- income individuals and families remain in their homes by repairing or replacing windows, doors, insulation, boilers, furnaces and hot water heaters.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The Passaic County Coordinated Assessment System prioritizes homeless persons and meets monthly to fill vacancies and house those on the list. The length of time someone is on the list is tracked. Further, the CoC is working with agencies to more quickly move persons who are homeless and living in shelters or transitional housing to permanent housing.

Through partnerships with the Children's Inter-Agency Coordinating Council (CIACC), education system partners, homeless liaisons, the behavioral health care system, child protective services and the homeless services system, homeless students and their families are identified and service plans developed to meet their needs. CIACC offers cross-training on homeless definitions, compliance and requirements, support systems for the homeless and effective community service providers. CIACC has developed a standardized intervention model for use in school settings to effectively determine the service needs of homeless children and connect them to appropriate providers.

The Passaic County Department of Human Services has hired a full-time veteran's services staff member to coordinate the goal of ending homelessness for veterans. Veteran Affairs Supportive Housing (VASH) staff members are active in the CoC and its sub-committees. This coordination has resulted in assistance to veterans in securing and maintaining housing. The veteran's subcommittee of the CoC, led by the local SSVF providers, has also created a by-name list for homeless veterans in

the CoC, ensuring they are connected to permanent housing as quickly as possible.

The PCICH is working to shorten the length of time persons are homeless by creating more permanent housing and rapid rehousing programs to quickly move clients into permanent housing. Through the coordinated assessment committee, the most vulnerable clients are targeted for housing opportunities including permanent supportive housing and rapid rehousing vouchers. Homeless Trust Fund dollars are reserved for rehabilitation of units for homeless families and homeless youth (18-24). As of August 2022, the County was continuing to distribute ERAP funds; services including prevention and diversion are available through Catholic Charities.

Reducing returns to homelessness is also being addressed by placing a priority on job training and services for persons who are homeless and in rapid rehousing and permanent housing programs. Additionally, there was a training held by the Director of the Workforce Development Board on how to connect CoC clients to jobs and training opportunities.

The CoC maintains 1,741 permanent housing beds, most of which are occupied with low turnover rates. The CoC submitted 4 housing applications through the regular CoC FY2024 application for permanent housing.

- CSPNJ New vouchers for Permanent Supportive Housing
- Volunteers of America-Greater NY New vouchers for Permanent Supportive Housing
- Heart of Hannah Additional vouchers for Rapid Rehousing
- Passaic County Department of Human Services Vouchers for Permanent Supportive Housing

The County budgeted \$30,000 in FY2023 CDBG funds for the County Court Appointed Special Advocates (CASA) program which assists foster youth make the transition to permanent housing and independent living.

### Actions taken to address the needs of public housing

There are no public housing units in the Urban County.

# Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

Passaic County has a Public Housing Agency which administers 843 Section 8 Housing Choice Vouchers. There are no public housing units within this Agency. The jurisdiction of the Agency includes all of the municipalities in the County with the exception of Passaic, Paterson and Clifton as these towns have their own Housing Authorities.

The Agency administers a Family Self Sufficiency program which has a minimum of 70 to 75 families participating each month. The families are recruited from the pool of tenants that are currently being assisted with rental subsidy. The Program is a five-year plan in which families work towards achieving goals that will enable them to become economically self-sufficient. The Agency partners with local entities that provide job training, interview techniques, clothes for employment, and other workshops which encompass a variety of topics from esteem building to financial planning. During the course of the five-year program, if the family's income increases and rental subsidy decreases, the difference is put into an escrow account for the family. The family receives the amount saved providing that they reach their goal during the five-year period and they have been working for the last 12 months.

From the period September 1, 2023 through August 31, 2024 the Housing Choice Voucher Family Self Sufficiency Program had ten graduates.

The Housing Agency was also selected by the Department of Housing and Urban Development to receive 29 Emergency Housing Vouchers through the American Rescue Plan Act. Seventy thousand of these vouchers were distributed on July 1, 2021 to housing authorities based on geographical need and the authority's previous ability to lease up families in their existing programs. These vouchers are targeted to assist individuals or families that are homeless, at risk of homelessness, fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking, or were recently homeless and have a high risk of housing instability. Any applicants for this program must be referred to the Housing Agency by the County Department of Human Services. The Housing Agency has leased all of its 29 vouchers. In order to the assist the families into transitioning into a new apartment, HUD has also supplied service fees which may be used for security deposits, realty fees, utility bills, and the purchase of household items, if needed.

### Actions taken to provide assistance to troubled PHAs

The Passaic County Housing Agency is not designated as troubled.

## CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Passaic County does not have jurisdiction over land use controls in compliance with the Municipal Land Use Law of the State of New Jersey. Building codes are also governed by state law and implemented by each municipality. There are no County policies identified that have a negative impact on affordable housing.

Over 51% of the County has been designated as the Highlands Region by the State of New Jersey. This designation substantially reduces or eliminates development in the Highlands Region and effectively eliminates the ability to create new affordable housing opportunities. In addition, these areas have limited water and sewer infrastructure and this also reduces the ability to construct new affordable housing units.

### Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

CDBG funds were not used for housing development nor homeless services in FY 2023. The County uses its Homeless Trust Fund to provide assistance to agencies that address homelessness in Passaic County.

CASA, funded by the Passaic County CDBG grant, serves youth who are removed from their families and become wards of the state. As advocates they act in the child's best interest and ensure that the children are receiving the services they need such as safe housing; attend school; and receive medical services. CASA assisted 32 children in FY 23 in the Urban County.

Other county offices such as the Human Services Department address homelessness and provides motel vouchers for overnight shelter, food and transportation vouchers and other immediate needs. The Passaic County Homeless Trust Fund provided a grant to NJ 2-1-1 to operate a homeless hotline and the development of coordinated entry services.

### Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The Passaic County Department of Health acts as the Health Department in five Passaic County municipalities: Wanaque, West Milford, Haledon, Prospect Park, and Woodland Park and addresses lead-based paint contamination through a \$400,000 grant from the NJ Department of Health. Passaic County Health Department Nurses test children for lead contamination, and perform Lead Case Management and Investigations of homes for lead contamination. Nurses and inspectors follow-up with patients to ensure that they receive adequate care and that lead based paint is remediated. The

Passaic County Department of Health also runs educational programming for adults and children regarding lead contamination risks. Other communities in the county have their own Departments of Health and are responsible for assessing the needs of children that present with elevated blood lead levels. Building code departments throughout the County are responsible for enforcing state laws prohibiting the use, and addressing the presence, of lead-based paint through their permitting process.

The Health Departments are keenly aware of the problems of lead-based paint. When lead paint has been identified in a unit constructed prior to January 1, 1978, only an EPA qualified contractor performs lead hazard reduction activities. New Jersey laws provide that a contractor must employ a certified lead-based paint abatement supervisor, or have employees certified in lead-based paint abatement. Certified testing companies perform a pre-rehabilitation risk assessment for lead-based paint hazards and a post-rehabilitation clearance test for lead dust hazards where the non-emergency work disturbs a painted surface.

The State of New Jersey offers Lead-based paint remediation through the Lead-Safe Remediation Pilot Program. Lower income households (both renter and owner) can qualify for assistance from the NJ Department of Community Affairs (NJDCA).

The Passaic County Division of Weatherization and Home Energy has received a grant from the NJ DCA through the Lead Assistance Program. The County has 6 contractors that perform lead remediation and lead abatement. To date, the Division assists 50 homes per year and has assisted 100 homes in total. The program is available for 1- 4 unit properties built before 1978 where the gross household income is at or below 80% AMI (Area Median Income) or if the househould is categorically eligible (i.e. residents receive food stamps; LIHEAP; etc.).

In its implementation of the Critical Repair Program, Habitat for Humanity performs lead testing and risk assessments as required, and utilizes lead safe work practices during rehabilitation and implementation of interim controls.

### Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

Through implementation of many programs outside of the CDBG program, Passaic County works with families to reduce the number of families with incomes below the poverty level. The Workforce Development Board (job training, apprenticeships and youth training) and the One-Stop Career Center create new job opportunities and offer training programs. The Passaic County Workforce Development Center; the NJ Department of Labor and the Passaic County Division of Economic Development works with small and medium sized business owners to expand their businesses, hire new workers, and take advantage of training and employee development programs such as On-the-Job Training Programs; UpSkills Training Programs; and the Return and Earn Program.

Additionally, the County, in conjunction with the public and private agencies and institutions, provides low-income households with the opportunity to gain the knowledge and skills to become fully self-

sufficient. The agencies participating in the Continuum of Care encourage job training and employment for those facing homelessness. Life skills counseling, drug and alcohol counseling and mentoring service provide a means to becoming employable.

### Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The County Department of Planning and Economic Development is responsible for the administration of the CDBG program. All sub-recipient agreements are monitored on an ongoing basis. The County participates with other groups, where appropriate, as it does its planning to address homelessness, to facilitate cooperative problem solving in Passaic County.

The current institutional structure provides a solid foundation for grant administration and maximizes the level of assistance that reaches the community.

The CoC is continually working to enhance its organizational strengths. The County has implemented a coordinated entry list in the Homeless Management Information System (HMIS) which is managed by NJ 2-1-1. All new applicants are entered into this system and referrals to open permanent housing slots are taken from this list. They are initiating efforts to enroll each warming center placement into HMIS for assessment for coordinated entry during Code Blue conditions.

# Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The County continued efforts to enhance coordination between agencies by creating partnerships in the implementation of the Section 3 outreach initiative and the Passaic County Interagency Council on Homelessness. The Section 3 outreach effort partners with the Passaic County Workforce Development Board and the agencies involved in the Human Services Advisory Board to identify Section 3 individuals and businesses and to provide feedback on available job opportunities. The Passaic County Interagency Council that administers the Continuum of Care is comprised of providers of homeless services and prepares the McKinney-Vento Continuum of Care application for funding from HUD.

# Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Passaic County completed an Analysis of Impediments to Fair Housing Choice (AI) in 2022 which was sent to HUD in September. The AI identifies barriers to fair housing and outlines action steps to address these impediments.

Barriers include:

- A. Lower employment rates and wages for certain members of the protected classes restrict housing choice
- B. Non-White households were less likely to be homeowners than White Households
- C. Moderate levels of segregation exist in Passaic County
- D. The land Use and Housing elements of the Master plan are outdated
- E. Planning documents in some municipalities are not consistent with fair housing laws.

### Actions to Address Barriers:

- A. Update the Land Use and Housing Elements of the Passaic County Master Plan.
- B. Provide technical assistance to local municipalities to create opportunities to develop affordable housing.
- C. Continue to provide technical assistance to municipalities to bring them into full compliance with the Fair Housing laws.
- D. Provide credit counseling to members of the protected classes and/or contract with a third party to provide this service.
- E. Engage HUD-certified housing counselors.
- F. At the annual Passaic County sponsored fair housing conference, provide education to the public about predatory lending practices.
- G. Raise awareness among new and existing local businesses of the benefits of partnering with the Workforce Development Board to assist in growing opportunities for meaningful employment, particularly for members of the protected classes.

During FY 2023, Passaic County hosted a Fair Housing Seminar, designed to provide guidance and education on fair housing compliance and information on how to expand housing opportunities in the County. Content included affordable lending products, an update for Passaic County Housing Agency landlords on Section 8 vouchers and compliance with HUD regulations, and a review by the New Jersey Division on Civil Rights of the state's fair housing law and new Fair Chance in Housing Act requirements; and a discussion on how to comply with the US Fair Housing Act. Information on Landlord Incentive Programs for Weatherization and Lead Paint Remediation were also provided.

The County continued to collect affordable housing plans from member municipalities to determine which municipalities have established plans to address its need for affordable housing.

### CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

Passaic County has adopted a subrecipient monitoring plan. This plan outlines the process for reviewing subrecipient activities throughout the year and for conducting on-site monitoring.

Subrecipient activities were monitored with each request for disbursement. Each request had to provide documentation of every expense and report on the number of beneficiaries served. Monitoring will occur again in late 2024.

Public improvements and infrastructure activities were monitored throughout the project. Each subrecipient is expected to research available MBE/WBE and Section 3 firms (as applicable) that might bid on or be interested in subcontracting for their project. These lists are made available to the general contractors who bid the projects as well. A checklist was used to ensure that each compliance requirement was met and that the project stayed on schedule. On-site inspections and employee interviews to demonstrate compliance with labor relations and prevailing wages were completed, and the County regularly receives and reviews certified payrolls. Payments are not made to the subrecipient municipalities until evidence of compliance is achieved.

The Department of Planning and Economic Development is the lead agency for the Strategic Plan and annual planning activities. Cooperation and support from local municipal governments, and private, non-profit, and for-profit organizations is sought throughout the year and during preparation of the Annual Plans.

### Citizen Participation Plan 91.105(d); 91.115(d)

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

The CAPER document was placed on public display for a period of 15 days from November 8, 2024 to November 25, 2024. A public hearing was held on November 15, 2024 to obtain comments on the County's performance.

Copies of the notice of the CAPER were distributed to organizations that could make the availability known to low- and moderate-income persons and those that speak English less than very well. The list of organizations that were notified is shown below.
