Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

RESOLUTION REQUESTING EXTENSION OF TIME TO AWARD PROJECT FOR MUNICIPAL AID FY2014 FOR HOBART PLACE
