MINUTES OF THE MAYOR AND COUNCIL

February 11, 2014

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

The Municipal Clerk read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. The agenda for this meeting has been prepared and distributed to the Mayor and Council and a copy has been on file in the Office of the Municipal Clerk.

There was a motion by Councilman Waryas, seconded by Councilwoman Fontanella to dispense with the regular order of business in order to hold a public hearing on Ordinance No. 02-2014 as advertised. On roll call vote, all members of the Council present voted in the affirmative.

Municipal Clerk Wassel announced that Ordinance No. 02-2014 has been advertised for public hearing for Tuesday, February 11, 2014.

Municipal Clerk Wassel read the legal notice and the title of Ordinance No. 02-2014.

There was a motion by Councilman Waryas, seconded by Councilwoman Fontanella to open the public hearing. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro asked if any citizens wished to be heard on Ordinance No. 02-2014.

CITIZENS HEARD:

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF TOTOWA CHAPTER 310 ENTITLED "SALES, SPECIAL", ARTICLE II, "SIDEWALK SALES", SECTION 12 (F), "PERMIT FEES" & SECTION 17, "RESTRICTIONS" (A) & (B)

There was a motion by Councilman Waryas, seconded by Councilwoman Fontanella to adopt Ordinance No. 02-2014 on second and final reading. On roll call vote, all members of the Council present voted in the affirmative.

There was a motion by Councilman Waryas, seconded by Councilwoman Fontanella to revert to the regular order of business. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro asked if any members of the Council, the Municipal Clerk or the Municipal Attorney wished to address the Council.

<u>Councilman Waryas</u>: Said that we've had a tough winter so far and more snow is expected—and heard that we've taken some shots from the public because there is no place to put the snow—but just wanted to thank our guys (some of whom are here

tonight) for their handling of the snow plowing. <u>Mayor Coiro</u>: Echoed those sentiments and said our streets seem pretty good compared to some other towns. Asked DPW Superintendent Jim Niland about our salt deliveries. <u>Superintendent Niland</u>: Responded we haven't received any deliveries yet, but we got two orders of grit and we'll mix it with the salt that we have left.

CITIZENS HEARD:

There were no citizens who wished to be heard.

There was a motion by Councilman Waryas, seconded by Councilwoman Fontanella to approve the Minutes of the Mayor and Council for the meeting of January 28, 2014. On roll call vote, all members of the Council present voted in the affirmative.

COMMITTEE ON FINANCE:

There was a motion by Councilwoman Fontanella, seconded by Councilman Picarelli to approve Resolution No. 2014-04 for the payment of bills. On roll call vote, all members of the Council present voted in the affirmative.

There was a motion by Councilwoman Fontanella, seconded by Councilman Picarelli to adopt the following Resolution Re: Establishment Of Change Fund For The Municipal Court. On roll call vote, all members of the Council present voted in the affirmative.

RESOLUTION NO. 30-2014

WHEREAS, the Municipal Court Judge of the Borough of Totowa has requested the establishment of a change fund to be used by the personnel located in the Municipal Court; and

WHEREAS, the Municipal Court Judge has further requested that the Court Administrator, the Deputy Court Administrator and the Violations Clerk each be responsible for their own change fund in an amount of \$200 each; and

WHEREAS, the Chief Financial Officer has reviewed this request and recommends the establishment of a change fund for the Municipal Court in an amount not to exceed \$600.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Totowa that a change fund be established in the amount of \$600 to be used by the Municipal Court.

RESOLUTION AWARDING CONTRACT FOR THE PURCHASE AND DELIVERY OF ONE NEW HEAVY DUTY RESCUE UNIT

WHEREAS, the Borough of Totowa Fire Chief had recommended to the Mayor and Council of the Borough of Totowa that a new Fire Truck be added to the Borough of Totowa Fire Department fleet for Fire Rescue Company No. 4, 22 Mitchell Avenue, Totowa, New Jersey 07512; and

WHEREAS, more specifically, the Borough of Totowa Fire Chief recommended that the Borough of Totowa solicit proposals for one (1) new International 4400/Rescue 1, Heavy Duty Rescue Unit #R-241 or approved equivalent that is the manufacturer's latest design and production; and

WHEREAS, the Mayor and Council of the Borough of Totowa did advertise for receipt of sealed bids in accordance with the specifications entitled "Specifications and Proposal for the Purchase and Delivery of One (1) New Heavy Duty Rescue Unit Or Approved Equivalent for the Borough of Totowa, County of Passaic, New Jersey 2014"; and

WHEREAS, the Borough of Totowa did receive bids at its Municipal Building on February 5, 2014; and

WHEREAS, the lone bid was submitted by P.L. Custom Body & Equipment Co. Inc., 2201 Atlantic Avenue, Manasquan, New Jersey 08736 for a 2015 International 4400, Rescue 1, Heavy Duty Rescue Truck in the amount of Two Hundred Ninety-Four Thousand Forty-Four and 00/100 Dollars (\$294,044.00) with delivery of the vehicle to be provided within Three Hundred Sixty (360) days from receipt of a signed contract, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the Mayor and Council of the Borough of Totowa on February 11, 2014 did examine the bid for the vehicle and all materials called for; and

WHEREAS, the Borough of Totowa Fire Chief has reviewed the bid and recommended the Borough of Totowa authorize the award of a contract to P.L. Custom Body & Equipment Co. Inc. for the purchase and delivery of one (1) Heavy Duty Rescue Unit and related equipment; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that the bid submitted by P.L. Custom Body & Equipment Co. Inc. be accepted as the lowest responsible bid.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the bid of P.L. Custom Body & Equipment Co. Inc. for the purchase and delivery of a 2015 International 4400, Rescue 1, Heavy Duty Rescue Truck in the amount of Two Hundred Ninety-Four Thousand Forty-Four and 00/100 Dollars (\$294,044.00).

WHEREAS, the Interim Superintendent for the Borough of Totowa Department of Public Works has reviewed the proposal and recommended the Borough of Totowa authorize the award of a contract to Trico Equipment Services LLC for the purchase and delivery of the new 2014 Case 580N Loader Backhoe and related equipment; and
