MINUTES OF THE MAYOR AND COUNCIL

January 10, 2023

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

Municipal Clerk Wassel read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. CITIZENS HEARD:

There were no citizens who wished to be heard.

There was a motion by Councilman D'Angelo, seconded by Councilwoman Andriani to approve the Minutes of the Mayor and Council for the meeting of December 27, 2022. On roll call vote, all members of the Council present voted in the affirmative.

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is a need for these Radar Speed Signs which are designed to slow cars down and make streets safer for everyone; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the purchase and delivery of the new Solar Digital Radar Speed Signs; and

WHEREAS, Elan City, 10-34 44th Drive, Long Island City, New York 11101 has submitted a proposal for the purchase and delivery of ten (10) Evolis Solution Digital Radar Speed Signs and related accessories in the amount of \$31,150.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the purchase and delivery of ten (10) Evolis Solution Digital Radar Speed Signs and related accessories from Elan City in the amount of \$31,150.00.

RESOLUTION NO. 28-2023

RESOLUTION TO AMEND RESOLUTION NO. 84-2022 FOR THE PURCHASE AND DELIVERY OF A FORD F-550

WHEREAS, by Resolution No 84-2022 dated June 28, 2022, the Mayor and Council of the Borough of Totowa authorized the purchase and delivery of one Ford F-550 to be added to the Department of Public Works ("DPW") fleet; and

WHEREAS, more specifically, the governing body authorized the purchase and delivery of one new 2023 Ford F-550 4x4 Truck with Spreader and Plow from Route 23 Auto Mall,1301 Route 23, Butler, New Jersey 07405 in the amount of \$85,055.00 pursuant to New Jersey State Contract No. 17-FLEET-00241; and

WHEREAS, Route 23 Auto Mall has advised the Borough of Totowa DPW Superintendent that delivery of the 2023 Ford F-550 4x4 Truck with Spreader and Plow has been delayed for at least 2 years due to supply chain issues being experienced in the automotive industry; and

WHEREAS, Route 23 Auto Mall further advised that the dealer currently has one new 2022 Ford F-550 Chassis 4x4 SD Super Cab Truck with Spreader and Plow that can be substituted for the 2023 Ford F-550 4x4 Truck with Spreader and Plow; and

WHEREAS, Route 23 Auto Mall has submitted a proposal for the purchase and delivery of one new 2022 Ford F-550 Chassis 4x4 SD Super Cab Truck with Spreader and Plow in the amount of \$94,920.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is still a need for this multi-function vehicle to be added to the DPW fleet; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the purchase and delivery of the 2022 Ford F-550 Chassis 4x4 SD Super Cab Truck with Spreader and Plow; and

WHEREAS, pursuant to the applicable New Jersey State laws, the purchase of this vehicle may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby amend Resolution No, 84-2022 dated June 28, 2022 to authorize the purchase and delivery of one new 2022 Ford F-550 Chassis 4x4 SD Super Cab Truck with Spreader and Plow from Route 23 Auto Mall in the amount of \$94,920.00.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Council of the Borough of Totowa do hereby authorize the Municipal Clerk and DPW Superintendent to execute any and all instruments relating thereto.

Upon the recommendation of DPW Superintendent Jim Niland, there was a motion by Councilman Bucher, seconded by Councilman Fierro to approve a grade increase for DPW Laborer Joseph Dulski from Grade 3 to Grade 2, effective January 16, 2023. On roll call vote, all members of the Council present voted in the affirmative.

A letter from the Passaic Valley Water Commission advising that they are increasing wholesale water rates by 6% for 2023 was received and filed.

A letter was received from DPW Superintendent Jim Niland requesting permission to switch the following holidays: Lincoln's Birthday, Monday, February 13th for Monday, July 3rd and Washington's Birthday, Monday, February 20th for the day after Thanksgiving, Friday, November 24, 2023. There was a motion by Councilman Bucher, seconded by Councilman Fierro to approve the request. On roll call vote, all members of the Council present voted in the affirmative.

COMMITTEE ON ENGINEERING & PUBLIC PROPERTY:

COMMITTEE ON LIAISON & INSPECTION:

There was a motion by Councilwoman Andriani, seconded by Councilman Bucher to adopt the following Resolution Authorizing The Borough Of Totowa To Apply For A New Jersey Department Of Community Affairs (DCA) – Local Recreation Improvement Grant (LRIG) Program FY23. On roll call vote, all members of the Council present voted in the affirmative.
