# MINUTES OF THE MAYOR AND COUNCIL

# October 27, 2015

PRESENT: Mayor John Coiro, presiding, Council President Phil Puglise, Councilman

Lou D'Angelo, Councilwoman Carolyn Fontanella, Councilwoman Debra Andriani, Councilman Anthony Picarelli, Councilman William Bucher, Municipal Clerk Joseph Wassel and Municipal Attorney Robert Corrado.

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

The Municipal Clerk read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. The agenda for this meeting has been prepared and distributed to the Mayor and Council and a copy has been on file in the Office of the Municipal Clerk.

There was a motion by Councilman Puglise, seconded by Councilman D'Angelo to dispense with the regular order of business in order to enable the Mayor and Council to present a Proclamation In Honor And Recognition Of Valentine Cholminski For Sixty Years Of Service To The Borough Of Totowa Fire Department and to hold a public hearing on Ordinance Nos. 18-2015 & 19-2015 as advertised. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro asked Council President Puglise and Fire Chief Vincent Marciano to join him and then asked Valentine Cholminski to approach the dais to receive the proclamation. Assistant Chief James Booth of Lincoln Fire Company also joined them.

Mayor Coiro remarked that it is always an honor to recognize a person that has volunteered as a fireman for 60 years and also contributed in other areas by serving as Engineer of Lincoln Fire Company and as President of the Totowa's Firemen's Exempt Association. Mayor Coiro then read some excerpts from the proclamation and presented the proclamation to Valentine Cholminski and expressed that we can't thank you enough.

Councilman Puglise commented that 1955 is a long time ago and it is great that you are still a fireman and we thank you very much.

Assistant Chief Booth announced that they would present a plaque on behalf of Lincoln Fire Company.

Fire Chief Vincent Marciano then congratulated Mr. Cholminski and gave some background on his history with the Fire Department. Thanked Val and said that he has been with the department for 30 years or the last half of Val's career. Also thanked the Mayor and Council for recognizing firemen at 50 and 60 years of service. #### RESOLUTION NO. 129-2015

RESOLUTION AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICES CONTRACT TO 1686 PUBLIC AFFAIRS, L.L.C. FOR CONSULTING SERVICES

WHEREAS, the Borough of Totowa, a public body corporate and politic of the State of New Jersey, is authorized pursuant to the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. (the "Local Public Contracts Law") to enter into contracts as deemed necessary for the efficient operation of the Borough; and

WHEREAS, McManimon, Scotland & Baumann, LLC, Special Counsel to the Borough of Totowa, has recommended that the Borough of Totowa retain the services of a public affairs consultant to provide assistance in working with the State of New Jersey in connection with certain redevelopment efforts; and

WHEREAS, Special Counsel had advised the Borough of Totowa that the public affairs consultant services constitute an extraordinary unspecifiable service in accordance with the Local Public Contracts Law, specifically N.J.S.A. 40A:11-5(1)(a)(ii);

WHEREAS, the Mayor and Council of the Borough of Totowa desire to engage the services of a firm to serve as public affairs consultant for the Borough of Totowa; and

WHEREAS, these service shall include but are not limited to establishing meetings with State officials, advising on procedural matters in the property acquisition process and working to gain reimbursement of expenses related to the property acquisition (the "Services"); and

WHEREAS, 1868 Public Affairs, L.L.C, 15 W. Front Street, Trenton, New Jersey 08608 (the "Contractor") has submitted a proposal to provide the Services, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, Special Counsel to the Borough of Totowa has reviewed the proposal and recommended that the Mayor and Council of the Borough of Totowa authorize and execute a contract with the Contractor for the Services (the "Contract"); and

WHEREAS, the Contract shall commence on December 1, 2015 and be for a term of six (6) consecutive months at the monthly rate set forth in the Contract.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the following:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. In accordance with the terms of the Local Public Contracts Law, the Borough hereby authorizes the Mayor to execute a Contract with the Contractor to provide the Services to the Borough for a term not to exceed six (6) consecutive months at the monthly rate set forth in the Contract.

Section 3. The Contractor shall provide the Services when and as directed by the Borough.

Section 4. A copy of this resolution shall be available for public inspection at the offices of the Borough.

Section 5. This resolution shall take effect immediately.
