Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

RESOLUTION NO. 125-2024

RESOLUTION AWARDING CONTRACT FOR RECYCLING COLLECTION SERVICES FOR THE BOROUGH OF TOTOWA

WHEREAS, the Mayor and Council of the Borough of Totowa did advertise for receipt of sealed bids for collection and transportation services for residential and municipal recyclable materials in accordance with its specifications entitled "Specifications and Proposal for Collection and Transportation of Recyclable Materials in the Borough of Totowa, County of Passaic, New Jersey 2024"; and

WHEREAS, the Borough of Totowa did receive bids at its Municipal Building on October 17, 2024; and

WHEREAS, the Mayor and Council of the Borough of Totowa on October 22, 2024 did examine all bids for the collection and transportation services called for in the specifications; and

WHEREAS, the lone bid was submitted by Get-A-Can, Inc., 278 Railway Avenue, Paterson, New Jersey 07503 with a bid in the amount of \$1,447,200.00 for a five-year period effective January 1, 2025 through December 31, 2029; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that the bid submitted by Get-A-Can, Inc. be accepted as the lowest responsible bid.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the bid of Get-A-Can, Inc. for the collection and transportation of residential and municipal recyclable materials for the Borough of Totowa for the sum of \$1,447,200.00 for the period of January 1, 2025 through December 31, 2029.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

There was a motion by Councilman Picarelli, seconded by Councilman D'Angelo to adopt the following Resolution Authorizing The Borough Of Totowa To Participate In A LEAP Implementation Grant. On roll call vote, all members of the Council present voted in the affirmative.

RESOLUTION NO. 126-2024

RESOLUTION AUTHORIZING THE BOROUGH OF TOTOWA TO PARTICIPATE IN A LEAP IMPLEMENTATION GRANT

WHEREAS, the State of New Jersey has appropriated funds for Shared Services and School District Consolidation Study and Implementation Grants to assist local units with the study, development, and implementation of new shared and regional services; and

WHEREAS, the Department of Community Affairs, Division of Local Government Services (DLGS) is tasked with administering these grant funds through the Local Efficiency Achievement Program (LEAP); and

WHEREAS, LEAP Implementation Grants exist to support costs associated with shared service implementation to ensure that meaningful, efficiency generating initiatives are not hindered by short term transitional expenses; and

WHEREAS, the County of Passaic and the Borough of Totowa propose to enter into a shared services agreement, but face certain expenses associated with implementation that present a burden to the local units; and

WHEREAS, the purpose of this shared services agreement is to provide low-cost, fiberoptic internet services to municipally-owned properties in Passaic County which will benefit the residents of all participating local units; and

WHEREAS, the County of Passaic has agreed to be the lead agency in this program and will submit the application to DLGS on behalf of all participating units.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby join with the County of Passaic in applying for a LEAP Implementation Grant in the amount of \$400,000,00 to support implementation of this shared service.

WHEREAS, the Borough of Totowa Department of Public Works ("DPW") Superintendent has advised that three of the garage doors at the Borough of Totowa DPW Building need to be removed and replaced; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is a need to dismantle and replace the garage doors at the Borough of Totowa DPW Building; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the removal and replacement of the garage doors; and

WHEREAS, the DPW Superintendent solicited quotes for the dismantling, removal and replacement of three garage doors at the Borough of Totowa DPW Building; and

WHEREAS, Reiner Overhead Doors, LLC, P.O. Box 246, Hasbrouck Heights, New Jersey 07604 has submitted a proposal dated October 4, 2024 for the removal and replacement of the garage doors in the amount of \$17,000.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, pursuant to the applicable New Jersey State laws, the removal and replacement of the three garage doors may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the removal and replacement of three garage doors at the Borough of Totowa DPW Building by Reiner Overhead Doors, LLC in the amount of \$17,000.00.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Council of the Borough of Totowa do hereby authorize the Municipal Clerk and DPW Superintendent to execute any and all instruments relating thereto.

WHEREAS, in anticipation of the upcoming Totowa, Woodland Park and Little Falls Holiday Parade, the Mayor and Council of the Borough of Totowa desire to make the Borough of Totowa Municipal Complex more festive with the installation of Christmas lighting; and

WHEREAS, to accomplish that goal, the Mayor and Council of the Borough of Totowa solicited quotes from licensed companies specializing in the installation of Christmas lighting; and

WHEREAS, K Hanrahan Enterprises, Inc., 20-21 Wagaraw Road, Building 36, Fair Lawn, New Jersey 07410 submitted a proposal dated October 6, 2024 for the installation of Christmas lighting in the amount of \$7,500.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, pursuant to the applicable New Jersey State laws, the contract for these services may be authorized without public bidding since the total contract price will not exceed the public bidding threshold.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by K Hanrahan Enterprises, Inc., for the installation of Christman lighting at the Municipal Complex in the amount of \$7,500.00.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize K Hanrahan Enterprises, Inc. to perform the lighting installation services as set forth in their proposal.

WHEREAS, Digital Totowa, LLC is the owner of real property commonly known and designated as Block 173, Lot 17 on the official Tax and Assessment Map of the Borough of Totowa and is located at 701 Union Boulevard in the I-3 Restricted Industry District; and

WHEREAS, Digital Totowa, LLC had filed an application for development with the Borough of Totowa Planning Board for preliminary and final site plan approval for the 701 Union Boulevard property; and

WHEREAS, the Borough of Totowa Planning Board at its public meetings held on March 14, 2013, April 11, 2013, April 25, 2013 and May 9, 2013 granted preliminary and final site plan approval for the application filed by Digital Totowa, LLC for the 701 Union Boulevard property, subject to certain conditions and restrictions; and

WHEREAS, Digital Totowa, LLC received approval to permit the construction of two data center buildings on the site inclusive of a substation with two electrical feeds in order to provide power to the proposed buildings on the site; and

WHEREAS, by Resolution No. 65-2013 dated May 14, 2013, the Mayor and Council of the Borough of Totowa authorized the Municipal Attorney of the Borough of Totowa to prepare the Developer's Agreement with Digital Totowa, LLC; and

WHEREAS, by Resolution No. 76-2013 dated June 25, 2013, the Mayor and Council of the Borough of Totowa authorized the Borough of Totowa to enter into the Developer's Agreement; and

WHEREAS, thereafter Digital Totowa, LLC sought approval for modifications to one of the buildings on the site which is also referred to as Building B and the Borough of Totowa Zoning Board at its public meetings held on November 4, 2020 and November 19, 2020 granted preliminary and final site plan approval for Building B; and

WHEREAS, by Resolution No. 125-2021 dated December 14, 2021, the Mayor and Council of the Borough of Totowa authorized the Municipal Attorney to prepare an Addendum to the Developer's Agreement between the Borough of Totowa and Digital Totowa, LLC; and

WHEREAS, by Resolution No. 27-2022 dated January 25, 2022, the Mayor and Council of the Borough of Totowa authorized the Borough of Totowa to enter into an Addendum to the Developer's Agreement; and

WHEREAS, thereafter Digital Totowa, LLC sought approval for modifications to one of the buildings on the site which is also referred to as Building A and the Borough of Totowa Zoning Board at its public meetings held on August 10, 2022 and September 14, 2022 granted amended preliminary and final site plan approval for Building A; and

WHEREAS, one of the conditions of the approval granted by the Borough of Totowa Zoning Board was the requirement that Digital Totowa, LLC enter into an Addendum to the Developer's Agreement with the Borough of Totowa; and

WHEREAS, by Resolution No. 117-2022 dated September 27, 2022, the Mayor and Council of the Borough of Totowa authorized the Municipal Attorney to prepare the Addendum to the Developer's Agreement between the Borough of Totowa and the Digital Totowa, LLC.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the Borough of Totowa to enter into an Addendum to the Developer's Agreement with Digital Totowa, LLC.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

RESOLUTION NO. 130-2024

RESOLUTION AUTHORIZING THE BOROUGH OF TOTOWA TO ENTER INTO A DEVELOPER'S AGREEMENT WITH G.O.M. REAL ESTATE INVESTMENT, LLC

WHEREAS, G.O.M. Real Estate Investment, LLC is the owner of real property set forth and designated as Block 11, Lot 9.01 on the official Tax and Assessment Map of the Borough of Totowa and commonly known as 95 Shepherds Lane, Totowa, New Jersey 07512; and

WHEREAS, the property is located in the R-AH-2 Affordable Housing-2 Zone District; and

WHEREAS, G.O.M. Real Estate Investment, LLC filed an application with the Borough of Totowa Planning Board for various land use approvals seeking preliminary and final major site plan approval with variance relief for the Shepherds Lane property for the construction of 2 buildings containing a total of 74 units for rent; and

WHEREAS, 59 of the units will be market rate and 15 of the units will be affordable housing; and

WHEREAS, the Borough of Totowa Planning Board at its public meeting held on July 9, 2020 granted preliminary and final site plan approval and various land use relief for the application filed by G.O.M. Real Estate Investment, LLC for the Shepherds Lane property, subject to certain conditions and restrictions; and

WHEREAS, the Borough of Totowa Planning Board approved the application on July 9, 2020 and memorialized its decision in a Resolution adopted by the Planning Board on August 13, 2020; and

WHEREAS, G.O.M. Real Estate Investment, LLC filed an amended application with the Borough of Totowa Planning Board seeking amended preliminary and final major site plan approval with variance "c" relief including track setback, building length, height and parking lot relief; and

WHEREAS, the Borough of Totowa Planning Board at its public meeting held on April 11, 2024 granted the preliminary and final site plan approval and various land use relief for the application filed by G.O.M. Real Estate Investment, LLC for the Shepherds Lane property, subject to certain conditions and restrictions; and

WHEREAS, the Borough of Totowa Planning Board approved the application on April 11, 2024 and memorialized its decision in a Resolution adopted by the Planning Board on April 25, 2024; and

WHEREAS, one of the conditions of the approval granted by the Borough of Totowa Planning Board was the requirement that the G.O.M. Real Estate Investment, LLC enter into a Developer's Agreement with the Borough of Totowa; and

WHEREAS, by Resolution No. 86-2024 dated June 11, 2024, the Mayor and Council of the Borough of Totowa authorized the Municipal Attorney to prepare the Developer's Agreement between the Borough of Totowa and the G.O.M. Real Estate Investment, LLC.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the Borough of Totowa to enter into a Developer's Agreement with G.O.M. Real Estate Investment, LLC.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.
