WHEREAS, copies of the 2023 Audit Corrective Action Plan have been distributed to the Mayor and Council of the Borough of Totowa and the Recommendations and 2023 Audit Corrective Action Plan have been forwarded to all affected personnel.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby acknowledge receipt of and accept the 2023 Audit Corrective Action Plan as prepared by the Municipal Clerk and Chief Financial Officer/Treasurer.

RESOLUTION NO. 121-2024

RESOLUTION APPROVING PARTICIPATION WITH THE STATE OF NEW JERSEY FEDERAL GRANT PROGRAM UNDER THE FY2025 SAFE AND SECURE COMMUNITIES PROGRAM ADMINISTERED BY THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY, OFFICE OF THE ATTORNEY GENERAL AND TO ACCEPT THE GRANT FUNDING

WHEREAS, the Mayor and Council of the Borough of Totowa wishes to apply for funding of approximately \$45,150 with a match of \$461,786 for an approximate project total cost of \$506,936 for a project under the State of New Jersey Safe and Secure Communities Program Grant # 25-1612 for the period of 01/25/2025 to 01/24/2026; and

WHEREAS, the Mayor and Council of the Borough of Totowa has reviewed the accompanying application and has approved said request; and

WHEREAS, the project is a joint effort between the New Jersey Department of Law and Public Safety, Office of the Attorney General and the Borough of Totowa, for the purpose described in the application.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Totowa that:

- 1) As a matter of public policy, the Mayor and Council of the Borough of Totowa wishes to participate to the fullest extent possible with the New Jersey Department of Law and Public Safety, Office of the Attorney General and to accept the grant funding in the amount of \$45,150.
- 2) The New Jersey Department of Law and Public Safety, Office of the Attorney General shall receive funds on behalf of the applicant.
- The New Jersey Department of Law and Public Safety, Office of the Attorney General shall be responsible for the receipt and review of the applications for said funds.
- 4) The New Jersey Department of Law and Public Safety, Office of the Attorney General shall initiate allocations to the applicant as authorized by law.

A letter was received from Lieutenant Jamie Titus asking to extend his retirement from November 1, 2024 to January 1, 2025. There was a motion by Councilman D'Angelo, seconded by Councilman Bucher to approve a fireman's application, the purchase of fireman's equipment and authorize a fireman's physical for Nicholas Molteni for Fire Rescue Co. No. 4. On roll call vote, all members of the Council present voted in the affirmative.

A letter from Chief Anthony Manna of the Fairfield Police Department thanking the Totowa Police Department for their support, love and sympathy due to the loss of one of their officers was received and filed.

There was a motion by Councilman D'Angelo, seconded by Councilman Bucher to add the following item to the agenda. On roll call vote, all members of the Council present voted in the affirmative.

A letter of resignation was received from Police Dispatcher Michael Antonuccio effective October 20, 2024. There was a motion by Councilman D'Angelo, seconded by Councilman Bucher to accept his resignation. On roll call vote, all members of the Council present voted in the affirmative.

COMMITTEE ON PUBLIC WORKS:

There was a motion by Councilman Bucher, seconded by Councilman Picarelli to adopt the following resolution approving a payment plan for a water customer due to a high water bill as a result of a leak in the sprinkler system. On roll call vote, all members of the Council present voted in the affirmative.

RESOLUTION NO. 122-2024

WHEREAS, the Borough of Totowa Water Department bills its customers based on three cycles, four times a year; and

WHEREAS, the second quarter billing period for Cycle 3 for 2024 is June 1, 2024 to August 31, 2024; and

WHEREAS, Michele Riccobono, 39 Winifred Drive, Block 166, Lot 10 is located in Cycle 3; and

WHEREAS, the Borough of Totowa Water Department meter reader noticed an unusually high meter reading and advised the homeowner; and

WHEREAS, the homeowner checked for leaks and found a leak in the sprinkler system, which resulted in second quarter 2024 billing for 225,000 gallons and \$2,062.00; and

WHEREAS, because of the extraordinarily high water bill, the homeowner has requested to be put on a payment plan.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby approve a payment plan for ninety (90) days with no interest, to be paid in three (3) installments of \$687.34 by October 31, 2024, November 30, 2024 and December 31, 2024.

BE IT FURTHER RESOLVED, by the Mayor and Council of the Borough of Totowa that if the entire balance isn't paid in full by December 31, 2024, then interest will be charged back to the original due date on any unpaid balance.

BE IT FURTHER RESOLVED, by the Mayor and Council of the Borough of Totowa that the Borough Clerk send a copy of this resolution to the Water Registrar.

RESOLUTION AUTHORIZING THE DEMOLITION OF THE DWELLING AT 63 NORWOOD TERRACE

Minutes 10/08/2024

WHEREAS, by Resolution No. 105-2019 dated August 27, 2019, the Borough of Totowa purchased property located at 63 Norwood Terrace in the Borough of Totowa and identified as Block 122, Lot 20 on the official tax map of the Borough of Totowa; and

WHEREAS, the Mayor and Council of the Borough of Totowa acquired this property with the intention of demolishing the existing structure and converting the property to open space for community-wide use; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to retain the services of a licensed contractor to demolish the existing dwelling structure on the property; and

WHEREAS, the demolition services include but are not limited to supplying all equipment to demolish the dwelling structure, removing the concrete footings and slab, dispose of all demolition debris and concrete, and backfilling the foundation with dirt to grade as required; and

WHEREAS, the Borough of Totowa Department of Public Works ("DPW") Superintendent did solicit proposals from licensed contractors to provide these services; and

WHEREAS, F. Antonucci & Sons, Inc., 283 Edmund Avenue, Paterson, New Jersey 07502 has submitted a proposal dated September 24, 2024 to demolish the dwelling structure located at 63 Norwood Terrace and provide all related services in the amount of \$12,200.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the Mayor and Council of the Borough of Totowa did on October 8, 2024, examine the proposal submitted by F. Antonucci & Sons, Inc.; and

WHEREAS, pursuant to the applicable New Jersey State laws, these services may be authorized without public bidding since it will not exceed the public bidding threshold.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by F. Antonucci & Sons, Inc. to demolish the dwelling structure located at 63 Norwood Terrace and provide all related services in the amount of \$12,200.00.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize F. Antonucci & Sons, Inc. to perform the services as set forth in their proposal.

BE IT FURTHER RESOLVED, that F. Antonucci & Sons, Inc. shall comply with all Federal, State and Local laws requiring permits prior to beginning construction and shall comply with all Federal, State and Local Ordinances and laws, including Borough of Totowa Code Book Section 336-4, while performing the aforementioned services.

BE IT FURTHER RESOLVED, that F. Antonucci & Sons, Inc. shall provide the Borough of Totowa with a one (1) year warranty on all workmanship and on all materials furnished for this project.

COMMITTEE ON LEGISLATION & ORDINANCES:

There was a motion by Councilman Picarelli, seconded by Councilman Reynoso to adopt the following Resolution Urging Amendment Of The New Jersey Bail Reform Act To Strengthen The Criteria For Pretrial Confinement For Certain Criminal Defendants. On roll call vote, all members of the Council present voted in the affirmative.

RESOLUTION NO. 124-2024

RESOLUTION URGING AMENDMENT OF THE NEW JERSEY BAIL REFORM ACT TO STRENGTHEN THE CRITERIA FOR PRETRIAL CONFINEMENT FOR CERTAIN CRIMINAL DEFENDANTS

WHEREAS, the Borough of Totowa ("Borough") is a municipal corporation of the State of New Jersey; and

WHEREAS, in 2017, the New Jersey Legislature adopted the New Jersey Bail Reform Act (the "Bail Reform Act"), which, among other provisions, eliminated cash bail for certain criminal defendants in favor of a risk-based system for pretrial detention; and

WHEREAS, the Borough agrees with the Bail Reform Act's intent that an indigent defendant should not be subject to pretrial confinement because that defendant is unable to afford cash bail; and

WHEREAS, the Borough, however, is concerned that the Bail Reform Act's bail reforms have had the unintended consequence of eliminating the ability of judges to set monetary bail for many categories of criminal defenders and that defendants are released without any option to impose bail, thereby allowing non-violent suspects, including repeat offenders, back in public shortly after arrest; and

WHEREAS, as a direct result of the bail reforms stated above, the Borough has experienced a significant increase in auto thefts and home invasions, many of which have been conducted by repeat offenders and juvenile defendants (some of whom are awaiting trial on previous offenses), who are aware that they will not be subject to substantial consequences for their criminal activity; and

WHEREAS, while the Borough applauds the State Legislature for adopting recent legislation to enhance motor vehicle theft and residential burglary laws, the Borough recognizes an urgent need for the State Legislature to reform the Bail Reform Act to enhance the safety of all Borough residents and business owners; and

WHEREAS, the Mayor and Council deem it in the best interest of the Borough, its residents and its business owners, to urge the New Jersey State Legislature to amend the Bail Reform Act to strengthen the existing risk-based detention system to set bail for defendants who pose a risk to public safety and provide judges with the discretion to set bail for defendants with 1) prior felony convictions; 2) prior failures to make an appearance in court; or 3) subsequent arrests while awaiting trial.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa hereby urges that the New Jersey State Legislature adopt amendments to the New Jersey Bail Reform Act as set forth in this resolution to strengthen the criteria of pretrial confinement for certain criminal defendants.

PROCLAMATION IN HONOR AND RECOGNITION OF THE 50TH ANNIVERSARY OF ST. JAMES OF THE MARCHES KNIGHTS OF COLUMBUS COUNCIL NO. 6574

WHEREAS, founded on the principles of charity, unity and fraternity, the Knights of Columbus was established in 1882 as a Catholic fraternal organization dedicated to promoting and conducting educational, charitable, religious and social welfare works, rendering mutual aid and assistance to sick and needy members and their families; and

WHEREAS, the Church of St. James of the Marches was established on July 4, 1926 in response to the need for a Catholic parish in the Borough of Totowa, New Jersey; and

NOW, THEREFORE, BE IT PROCLAIMED by the Mayor and Council of the Borough of Totowa that special recognition is given to the St. James Knights of Columbus Council No. 6574 for their 50 years of devotion and service to their Catholic faith and their community.
